Letter from the President

Dear RC25 members,

The success of the program at Toronto is based on your wonderful presentations, but also on the participation of sessions organizers, and on the work of the program coordinators, who prepared each steps and dealt with all unexpected related issues. So, I would like to start this letter with thanks. Notably, I would like to highlight the tremendous work of Amado Alarcon, Federico Farini and Keiji Fujiyoshi as program coordinators for (one of) the biggest program of RC25 (22 sessions). They included two keynotes for the first time, to my knowledge. I am thankful to Celine-Marie Pascale and Roland Terborg for their stimulating presentations, which illustrated the diversity of our RC, and once more underline that what unites all of us is the desire to look at rather than through systems of communication.

The previous RC25 awards were also modified to dedicate one award to the best article published in Language, Discourse & Society, the journal published by RC25, and the other one to a broader scope. On behalf of the executive board, I would like to warmly thank Cecilio Lapresta-Rey for his leadership as chair of RC25 awards.

At Toronto the executive board was partially renewed, with a shift for several positions. Before welcoming the new board, on behalf of the previous and present board I want to express our gratitude to Federico Farini, Nadya Georgieva, and Trinidad Valle for having served as Vice-President, Treasurer, and Newsletter Editor. I am also grateful to all the past boards: their work enabled such a vivid and vibrant RC community today.

Following the elections, the new board is formed by Keiji Fujiyoshi (Vice President), Viviane Resende (Secretary), Amado Alarcon (Treasurer), and Anna Odrowacz-Coates (Newsletter Editor). Initially not filled, the position of webmaster is now in the good hands of Maud Mazaniello-Chezol, who is notably renewing the website. Keiji Fujiyoshi will continue to lead our Facebook page, which nourishes our day-to-day link with the RC. I am happy to share the responsibility of serving all RC members with wonderful colleagues, who also bring with them the experience of having already successfully served the RC. I am thankful to benefit from their advices to support and anchor the initiatives toward the enhancement of our scholar community. And I am enthusiastic about the exchanges we already have for the RC!

Next Forum of Sociology will be held at Porto Alegre, Brazil, 14-18 July 2020. The thematic of the fourth Forum will be known by December 2018. I will coordinate the program with Keiji Fujiyoshi, Nadya Georgieva and Amado Alarcon. I warmly thank them for sharing this rewarding challenge. Indeed, as for each Forum, the number of sessions is slightly smaller than for World Congress, while there are so many very good abstracts. Nevertheless, we will be able to organize a significant program, also with the partnerships of other RC through joint sessions. The next step to organize the Forum for RC25 is the call for sessions, which will be running from February the 4th to March the 15th 2019. Already in December-January, do not hesitate to contact the program coordinators to exchange about the sessions you envision. You will also be contacted about your interest in organizing a regular session, joint sessions or any other kind of sessions you wish to enrich the exchanges for our community of scholars (roundtable sessions, etc.).

During the World Congress in Toronto, the board of ISA was also renewed. Geoffrey Pleyers, the new ISA VP research, started an ISA VP Research letter series to enhance the communication among ISA RC/WG/TG presidents and between the presidents and the ISA Executive Council. These letters are directly sent to all presidents and secretaries, but/and they are also published on ISA website: you may find the two first letters (and all the letters to be published in the future) following this link: https://www.isa-sociology.org/en/research-networks/research-

Also, he created the first "who's who" of presidents, which is also a document openly available online: https://www.isa-sociology.org/frontend/web/uploads/files/directory_isa_rc_presidents_2018_2022.pdf. The executive board welcomes all feedback/idea/initiative you may want to see growing following the reading of these letters.

The dedicated mailing list, which links all presidents and secretaries, is used to enhance the communication between RC/WG/TG to share organizational matters, but also any topic identified as relevant. Recently, the results of the Brazilian presidential elections were discussed in relation to the organization of next Forum in Porto Alegre. Concerns were shared, and strong support was expressed toward our Brazilian colleagues. All the board is looking forward to meeting you at Porto Alegre and to assisting to your presentations. RC25 members will be kept informed.

RCs are supported to develop themselves and their projects.

One of the main objectives of Geoffrey Pleyers as VP research is to help RCs to develop themselves and their projects. I already shared the initiative of RC25 to reflect more on how to disseminate research in multiple languages during conferences. Please share any idea/tool you experienced and that may enhance multilingualism to exchange about our research. I also would like to enlarge this concern to the dissemination of the literature which is not known just for a matter of non-translation (in English). I believe that RC25 is a good place to take care about a linguistically diverse knowledge production and dissemination. This is one project: do you see other projects you wish to see developed within our RC?

ISA has three official languages: English, French, and Spanish. I encourage scholars whose main language is



English to experience, if they wish and have some knowledge in French or Spanish, to do their presentation in French or Spanish and project their slides in English. This would be a multidimensional experience toward language and society, experiencing what the majority of our colleagues are doing during conferences (presenting in a language, English, they may be less comfortable than in another one). What do you think?

The deadline for submission is the 10th December 2018. This issue will be published in June 2019.

The following thematic issue, about Political Discourse and Historical, Colonial and Neo-Colonial Regimes of Power, is edited by Gatitu Kiguru (Kenyatta University, Kenya) and Phyllis Mwangi (Kenyatta University, Kenya). The deadline for the submission of abstracts is the 31st January 2019. Then the full articles are expected for the 31st of May 2019. This issue will be published in December 2019.

During the Congress the RC25 LANGUAGE & SOCIETY distinguished career award was announced and received by Florian Coulmas.


Amongst the keynote speakers, we had pleasure to listen to RC25 Key note speakers:



RC 25 AWARDS

In the context of the XIX ISA World Congress, that took place in Toronto last July, were announced the winners of the RC25 Awards.

Before anything else, some changes have occurred to the Awards in relation to the previous editions. First of all, the old Graduate Student Award and Academic Excellence Award merged in one called Award for Academic Excellence.

Secondly, it was considered advisable to create a new award to recognize career excellence in the field of language and society: The Language & Society Distinguished Career Award.

Report of Open Forum "Respecting the Past, Empowering the Future: Three Decades at the GLBT Historical Society"

Dear Colleagues,

I am happy to report you about a successful series of lectures conducted by our research project on the role of archives. The open forum titled "Respecting the Past, Empowering the Future: Three Decades at the GLBT Historical Society" was held in three places in Japan, Fukuoka, Kyoto and Tokyo from 10th to 14th September, 2018. We invited as keynote speaker Gerard Koskovich who is one of the founding members of the San Francisco GLBT Historical Society. The Society, founded in 1985, established the museum dedicated to the history of LGBT people. They have been making efforts to recognize and respect their past that was not necessarily always bright and happy. How to represent their community's past has a close relationship with how to recognize the present situation of their community. Our forums held in English provided an inspiring opportunity for Japanese audience to reflect their attitude toward their past. PRESIDENT OF RC25 2018-2022

Being both a sociologist and an economist, I am researching in a publicly funded research institution, which works in close relation with the Walloon Housing Ministry, and the housing administration and stake holders. My scholarship is first anchored in the categorization processes toward identities — I analysed skin colour/race declarations in Brazil to understand how they are constructed for 15 years (University of Auvergne, of Strasbourg, and of Paris-Est-Créteil, France). I also worked about cultural practices in Luxembourg at CEPS/INSTEAD (current LISER, Luxembourg). The overarching principles of my research are understanding preferences, behaviours, mainly looking at language. I use mixed methods from fieldwork to modelization and statistical analysis. Since 2010, I am thankful to be able to contribute to RC25's life and development in various ways. Nominated chair of the awards, I created and implemented three editions (2010-2016) and this position was successfully transmitted. I was secretary (2014-2018), and nominated

editor in chief of *Language, Discourse and Society* since 2016: *LD&S* is the journal published by RC25 since 2011. As RC25 president, beyond the expected duties to fulfill, I would like to reflect with members about the question of language in our RC, and how to deal with it in concrete ways in our communication and during conferences. Member of ISA since 2010, I am also member of RC05 (since 2014), and RC43 (since 2017). In addition, I was member of RC45 (2010-2014). I regularly organize joint sessions with RC30 and RC05.

Keiji Fujiyoshi is a Professor at Otemon Gakuin University, Osaka, Japan. His research concerns roles of archives in a society. In other words, he is interested in how people in a society deal with the past as their common heritage. He has ever convened three sessions on the theme in 2008 (The 38th World Congress of the International Institute of Sociology (IIS) in Budapest, Hungary), in 2010 (The 83rd Annual Meeting of Japan Sociological Society (JSS) in Nagoya, Japan) and in 2012 (The 40th World Congress of IIS in Delhi, India). He joined the ISA RC25 in 2014 when the 18th World Congress of the ISA was held in Yokohama, Japan by the invitation of Dr. Celine-Marie Pascal whom he met at the IIS Congress in India. He then joined the RC25 board as Webmaster and enjoyed his role under the presidency of Amado Alarcón Alarcón from 2014 to 2018. He also enjoyed as a role of program coordinator with Amado Alarcón Alarcón and Federico Farini at the ISA Forum in Vienna and Congress in Toronto. He is happy to pass

Yellow — exams - Blue — first semester (dark blue is marking) , Green — second semester (dark green marking)— dates vary every year March is the month of pre-University selection — the ENTRY EXAMS

ACADEMIC YEAR in Japan starts in April and finishes in March; Early April - beginning of the first semester

Late July - examination week

Early August - marking week and the end of the first semester Middle August - Middle of September - academic staff has a break from teaching, administration works as normal

Middle September - beginning of the second semester (A week break for New Year)

Middle of January - examination week

Late January - marking week

February - no teaching, preparation for the new academic year (information provided by Keiji Fujiyoshi) Japanese Academic Calendar

* Spring semester: From early April to late July or early August

Spring semester begins in early April. Faculty members have a lot of task for guidance and orientations for students.

About a week of term-end examination is held around late July or early August.

About two weeks of scoring of term-end examination is scheduled in

Spring semester ends in the middle of August.

Summer vacation is from August to September (The term differs depending on the university's calendar).

In summer vacation, many universities hold the event of 'Open Campus' for high school students and their parents and faculty members are busy for that.

* Autumn semester: From the middle of September or early October to late January

Autumn semester begins in the middle of September or early October. Faculty members have a lot of task for guidance and orientations for students.

About ten to fourteen days of winter vacation is from late December to Early January.

About a week of term-end examination is held around late January. About two weeks of scoring of term-end examination is scheduled in late January or early February.

Spring semester ends in the middle of February.

From late autumn the entrance examination begins. It is held in several forms from Admission Office Examination to Paper Examination from late autumn to late March next year. They exploit the faculty's energy. The burden varies according to the rank of the university (Of course good universities don't need to hold so many entrance examinations.

ACADEMIC YEAR in Poland runs - 01.10-30.09

Academic year starts on 1st October each year. It consists of 2 semesters. The first semester ends in February with two weeks of examinations and a week of staff break.

There is a generous Christmas/New Year break between 24th of December and 2nd of January.

The second semester starts and finishes in June with two weeks for examinations at the end. There is a short Easter break usually starting on Thursday and finishing on Tuesday.

The University operates at full speed until mid-July (with MA thesis defenses and end of academic year reports). Then it comes to a hold for over a month. Admin staff works as normal, enjoying the piece. Most academic staff takes their annual leave between 15th of July and beginning of September, as you are generally not allowed to take it during teaching months. September is the time for reseats and re-takes of exams and a last chance to defend MA and Bachelor thesis from previous semester. Most academic staff returns to work between 10th and 15th of September to prepare for the beginning of new academic year, which always starts on the 1st of October.

The conclusion is that although our semesters are scheduled differently, there is some overlapping holiday time in August both in Poland and in Japan.


A NOTE FROM THE RC25 WEBMASTER


Homepage of the RC 25 website

Foucault contends that 'power is everywhere', diffused and embodied in discourse, knowledge and 'regimes of truth' (Foucault, 1991). The view of power as a regime of truth acknowledges the fact that power is in a constant state of negotiation. A critical study of political discourse can reveal the discursive practices that shape the prevailing power structures, sustain and challenge them. Regimes of truth are discursively defined, reinforced and redefined and the avenue for this issocial institutions (education, religion, law, media, political, economic etc.). These discursive practices shape society and the power asymmetries in it. The traditional view of power is almost always negative. However, it is important to remember that power need not always be negative. It is true that power 'excludes'; it 'represses'; it 'censors'; it 'abstracts'; it 'masks'; it 'conceals'. However; it is also true that power produces: it produces reality; it produces domains of objects and rituals of truth(Foucault 1991). The fluidity of power allows the powerless to stage resistance.

This thematic issue of Language, Discourse, & Society welcomes both theoretical and empirical articles that focus on how political discourses in historical, colonial and neo-colonial contexts replicate and reinforce dominant regimes of power. It also





structures of power are discursively challenged and even reengineered through discourse in micro-relations that are the capillaries of normal everyday practices (Välikangas, A &Seeck, H, 2011). The thematic issue specifically encourages contributions rooted in the sociology of language, sociolinguistics, but also which take an interdisciplinary approach to the call topic and thus employ the methods of critical linguistic enquiry to economic, political and sociological problems.

<u>Sheng: Rise of a Kenyan Swahili Vernacular</u> by Chege Githiora:

A unique phenomenon in the study of linguistic change and innovation in an African context, Sheng is a reflection of the ethnolinguistic diversity of Nairobi and language asymmetry created by socioeconomic disparities. It also provides a window into understanding the processes of multilingualism, specific within the space structuring of Nairobi city. Nairobi provides a rich context for the study of many types of sociolinguistic phenomena, a context aptly described by Abdulaziz (1997) as one of "unstable multilingualism". 
